

Case studies

Accountant A

Scheme optimisation

Accountant A has always had a FPI scheme, and would provide details to any clients that made an enquiry. The total premiums collected from their clients just covered the cost of running the scheme. We worked with the accountant to understand the financial benefits to the practice and the value of the cover for their clients. Different pricing options were discussed, with Markel UK providing examples and case studies of how similar accountancy practices had turned around their schemes.

As a result of these discussions, it was agreed that Markel would run a direct mail campaign to all of the practice's clients who didn't currently subscribe to the scheme using a new and improved pricing structure.

Following the initial mailing and subsequent follow-up mailings, the accountant increased their client subscription rate fourfold and also generated an additional income stream for the practice.

Accountant B

Building a valuable income stream

Accountant B had an FPI scheme in place with another provider for a number of years but subscriber numbers had been dwindling. The client had undertaken little active promotion due to limited administration capacity and the day-to-day pressures of running a busy family practice.

Our area sales manager worked with the practice to understand these pinch points and ensure a smooth transition to Markel Tax — from back office support to utilisation of our mailing service to boost uptake of the scheme. In the first year we helped the client achieve double the number of subscriptions to their service, and ensured that fee protection added a valuable income stream rather than an additional administrative burden.





R&D tax relief

The opportunity

Research and development (R&D) tax relief is often overlooked by UK companies and their advisers but can prove highly lucrative. Eligible companies can benefit from tax relief whether they're loss making or profitable. Depending on the tax position, the benefit is available either as a tax refund or as a reduction of future corporation tax liability.

Markel Tax has a growing team of highly skilled in-house technical consultants with a blend of financially qualified CTA, ATT, ACA, alongside science and technology backgrounds, including PhD scientists, technologists and engineers covering many sectors. In addition, we are in the unique position in the market having direct access to over 25 in-house software engineers.

We offer a free research and development tax credit health check where one of our specialist tax consultants will ascertain eligibility for an R&D tax claim through extensive desktop research. The results will be shared with your practice and will put you in full control of your client's R&D tax affairs, as you'll be in the position to proactively take these opportunities to them.

An R&D tax credit is worth up to 33% of qualifying expenditure and, on average, businesses receive a tax benefit of £57,330 per claim. We also look retrospectively as businesses have 24 months from the end of the relevant accounting period to secure their tax relief.

Attempting to make an appreciable improvement to new or existing products, technology, processes or services, although this does not necessarily mean groundbreaking, innovative, or novel work. If companies are aiming to make their products or process cheaper, faster, smaller, or better in some way, then this may qualify as R&D. Partnership with our clients and will never compete for business.

Overcoming technological or scientific uncertainties or challenges, especially if the solution will not be immediately obvious to a qualified professional. The company may need to go through a "trial and error" process to achieve the required solution.

Capital allowances

The opportunity

Over half of UK businesses do not claim their entitlement to capital allowances, which could be worth hundreds of thousands of pounds. Tax claims can be maximised by consulting with a Markel Tax specialist before incurring any expenditure on commercial property.

Typical properties that benefit from capital allowances include:

- Purchase of an office building allowances available on initial investment plus further claim on any redevelopment costs
- Hotel acquisition and refurbishment, including serviced apartments
- Restaurants and entertainment venues
- Residential care homes, nurseries and holiday lets
- Student accommodations.

How can this benefit your clients?

Your clients could be claiming up to 19% of the eligible costs — with many claims being understated. Markel Tax can ensure that all claims, both future and past, are maximised and that all qualifying expenditure is correctly identified. To justify your claim, we prepare a full report of qualifying expenditures that will stand up to an HMRC audit.


